Dear Ms. Fulton,

The Dean Park Estates Community Association (DPECA) Executive is engaged with our residents and other community groups to address the urgent need to reduce the wildfire risk in ŁÁU,WELNEW/John Dean Park.

The Problem:

As you are aware, BC Parks did engage in some "fuel-reduction" activities in the park last winter/spring. However, this work was never completed and many of the debris piles were never disposed of or burned. Further, many dead or hazard trees which had been identified for removal or trimming were marked but never dealt with at the time. Other dead "ladder trees" or hazard trees which should have been removed based on the criteria for the stated work plan, were not dealt with or removed.

"Treatment will include the pruning and removal of ladder fuels - lower tree branches and smaller trees that could allow a fire to spread to treetops, reducing surface fuel load, and removing some trees identified as a hazard to the crews undertaking the treatment." (See attachment 1.)

The Evidence:

In our efforts to evaluate the seriousness of this issue after complaints from several of our residents, members of our Executive visited the homes of Dean Park Estates residents on Cathedral Place and Carmanah Terrace. We personally inspected the area behind several homes on those streets and photographed the debris piles and other hazards. We had hoped that some of the debris piles had merely been overlooked by the clean-up team. However, we also contacted residents on the other streets which border £ÁU,WELNEW/John Dean Park. Then it became clear that **every home** which we visited that shared a boundary with the park had similar debris piles and hazards. It now appears that all 38 residences on the west side of Cathedral Place, Echo Place West, Minstrel Place and Carmanah Terrace are adversely

affected. We also photographed properties in those areas. These pictures are attached in Appendix 2.

Most of the residences along the park boundary have done their best to implement FireSmart principles on their own land. However, these efforts would be fruitless if a fire began in the park so close to their boundary. Photos in Appendix 2 show these efforts.

An email from John Trelford, Chief of the North Saanich Fire Department on July 7, 2023, stated that he was aware of the debris piles bordering on Dean Park Estates residences and that the fuel reduction work in the park had not been completed as planned. This email also has attached emails from others involved (including BC Parks staff) **acknowledging their awareness of the situation**. (see Appendix 3)

DPECA and our residents have already written to BC Parks and left phone messages several times over the last few months. However, we have not had any reply or seen any other action. In our efforts to increase community awareness of the situation and to get some attention to this matter, we have already consulted with the following:

- John Trelford, Director of Emergency Services, North Saanich Fire Department,
- · Mayor and Council Members, District of North Saanich,
- North Saanich Wildfire Prevention Committee.
- · North Saanich Residents Association,
- · Pauguachin First Nations Administrator.
- · Friends of John Dean Park, and
- · Residents of Dean Park Estates.

The PROPOSAL for Immediate Action:

Given that North Saanich is already rated as an EXTREME Fire Risk, that the entire island is rated as Drought Level 4, and that there have already been a record number of wildfires in BC this year, we feel that it is imperative that the fire risk in ŁÁU,WELNEW/John Dean Park. should be dealt with *before* the situation worsens.

Because the work on this project was never completed and was still underway in March 2023, it is now too late to use burning to remove the accumulated debris. Our current proposal is that the *debris be removed from the area, mulched and hauled away as soon as possible*. It would be negligent to leave it in place and "hope" that nothing happens this summer or this fall until it can be burned in winter 2023. It would only take one careless cigarette, one lightning strike, or one person with bad intentions to turn the park and the surrounding area into a disaster.

This debris removal can be achieved in two ways:

- The debris can be dragged from the adjoining land through the back yards of each of the 38 residences bordering the park, around the homes, and down the driveways onto the streets. It could then be mulched and hauled away in trucks to the local green waste area.
- 2. Another option would be to drag the debris onto the Barrett Montfort Trail within the park and then use an ATV with a trailer to haul the debris back to the area near the park gate on

Dean Park Road. From there it could be mulched, loaded onto trucks and hauled away. In most cases this would require less labour, less time and lower costs since the distance to the trail is shorter than the distance through the residents' yards and to the streets. Since this option would be completed wholly within the park, there would be no need to get permission to operate on residents private property. (See Appendix 4 and Appendix 5.)

We do understand that there will be a cost to BC Parks for completing this work. However, the cost of doing *nothing* would be much greater. ŁÁU,WELNEW/John Dean Park is a treasure to all those in our community. Even a small fire could damage the irreplaceable sacred sites in the park and one of the last stands of old-growth Douglas-fir and Garry oak on the Saanich Peninsula. If the fire spreads to adjoining properties, it could impact all those who are neighbours of the park including: the Pauquachin First Nation, the farms and properties on the west side of the park as well as the residences in Dean Park Estates. Such a fire could also result in multi-million dollar property damages and potential injuries to all these residents. Since the Fire Departments in the area have limited resources, they would be forced to focus on evacuating residents from the area rather than fighting the fire. Evacuating more than 800 homes in the area would be a massive undertaking - especially when many residents are elderly.

Proposal for Annual Fuel Reduction:

In addition to the immediate action needed that is outlined above, BC Parks should commit to annual fuel-reduction efforts with work beginning every November and with removal or burning completed by February each year. Conclusion:

We sincerely hope that we can work collaboratively with BC Parks and others to address this urgent situation. We look forward to your prompt reply by email or letter. If we do not hear back within 10 days with a commitment to some action, we feel we have a responsibility to notify other residents of North Saanich and Saanich via the local media about this serious and dangerous situation. Of course, we would much prefer that your group immediately follow one of our two removal suggestions. When the work is completed, we would be happy to post in our newsletter, on our website and to other media about the helpfulness and proactive actions of BC Parks in reducing this serious fire threat to our community.

Wildfire Risk Reduction – Notice of Fuel Treatment in ŁÁU, WELNEW / John Dean Provincial Park

Dates: November 2022

Pile burning may occur later depending on burn windows

Agency Responsible: Ministry of Environment & Climate Change Strategy - BC Parks

BC Parks plans to continue implementing a fuel management prescription at-ŁÁU, WELNEW/John Dean Provi Park this November 2022.

In 2011, 2016 and 2018, BC Parks engaged registered professional foresters from the BC Wildfire Service (BCWS) to condwildfire threat assessments of key interface zones in ŁÁU,WELNEW/John Dean Provincial Park and undertook the fuel management recommendations of those professionals around key infrastructure at the mountain summit. In 2019/20, B Parks reengaged a professional firm to conduct a more targeted threat assessment of the forested area close to the easter boundary of the park and the park's evacuation route (road and parking lot). As part of that work, a fuel management prescription was drafted to address the areas at increased risk of wildfire. This fuel treatment prescription was implement a 2020/21 along the eastern boundary of the park.

BC Parks is now notifying you as a neighbour of the park of its plans to continue implementing that fuel management prescription this November 2022. BC Parks in partnership with the BC Wildfire Service will remove accumulations of flammable material ("fuel") in identified, targeted areas close to private residences, and the road/parking area within the park (see attached map for more detail). Removing this excess fuel will reduce the severity and spread of a wildfire from the park to neighbouring properties and vice versa, and it will help reduce the risk of fire spreading from the ground to the tops of trees. This work will also make it easier and safer for firefighters to respond in the event of a wildfire to protect nearby homes. Lastly, this fuel treatment will enhance the resilience of the park's old growth ecosystems by reducing fire threat.

The treatment will cover approximately 7.8 hectares in two distinct areas of the park: the eastern boundary (5.3ha) and the roadway (2.5ha). Treatment will include the pruning and removal of ladder fuels – lower tree branches and smaller trees that could allow a fire to spread to treetops, reducing surface fuel load, and removing some trees identified as a hazard to the crews undertaking the treatment.

To address possible impacts to conservation values of the park, BC Parks commissioned a professional ecological assessment of the proposed treatment area and will be undertaking all mitigation measures recommended in that assessment. For example, to mitigate negative impacts to sensitive plant and animal species, the treatments have been timed for the time of year that will have the least impact on those species and no heavy machinery will be used within forested areas; all treatments will be completed by hand.

Work is estimated to begin October 31st, 2022. Although specific dates are subject to weather and crew availability, generally work will occur Monday to Friday between 9:00am and 4:00pm. Crews will be working in targeted areas along

the eastern boundary of the park, sometimes within sight of the homes along the park boundary. Residents near the park will likely hear noise (e.g. chainsaws) from crews during the course of their work. Smoke from controlled burn piles may be observed – please note all burning will be conducted and

monitored by qualified BCWS professionals. Pile burning may occur after November depending on wind and weather windows.

Due to the limbing of some trees and other work, including pile burning, periodic and temporary trail closures will be needed for the safety of park users. BC Parks and BCWS staff will be posting notification signs at trailheads. Continuous passage on some trails may be blocked. The ŁÁU,WELŊEW / John Dean Provincial Park webpage will be updated weekly with trail closure information.

Good afternoon Marsha, I'm glad you have noticed the efforts BC Parks has given to John Dean Park. As you can see in the correspondence below the project is ongoing and they will continue to burn debris in the Fall 2023. Projects of this size take a great deal of time to complete due to terrain and weather but also a small window of time each year that they are able to burn to ensure it is not a nuisance to surround residential properties in the area. I am aware of the piles that have not yet been dealt with and with speaking to crews in the area while performing the work they are not considered a threat to wildfire. John Dean Park as well as others in our area that are Federal or fall under the CRD are not within our jurisdiction therefore the District does not conduct wildfire mitigation for those areas.

I hope this is helpful.


